Membership Categories / Fees (1/7/2012 - 30/6/2013)

Ordinary Membership **\$220.00**

A person 18 years of age or older shall be eligible to hold office and enjoy full Club privileges

Recreational Membership **\$60.00**

Shall enjoy all Club privileges but shall not be eligible to

- Play in Club Championships
- Play in more than 2 pennant games
- Hold any office or vote at a General Meeting
- Propose or second any Membership application

Community Bowler Membership **\$50.00**

Shall enjoy all Club privileges but shall not be eligible to

- Play in Club Championships
- Hold any office or vote at a General Meeting
- Propose or second any Membership application

Junior Membership **\$60.00**

Shall be 12 years of age & no older than 18 years of age who may enjoy Club privileges but shall not;

- Propose or second any Membership application
- Hold any office or vote at a General Meeting
- Not permitted to purchase or consume alcohol or gamble on Club premises
- Invite guests into the Club without Executive Committee approval

Social Membership **\$25.00**

Shall be 18 years of age or older who can enjoy privileges of the Club but shall not be eligible to;

- Use the Clubs greens without Executive Committee approval
- Propose or second any Membership application
- Hold any office or vote at a General Meeting

Reciprocal Membership **\$60.00**

A current Ordinary Member of another Bowling Club Affiliated with Bowls WA or similar Association throughout Australia. Shall be entitled to the privileges of the Club but shall not be eligible to;

- Play in any pennant match, represent the Club or play in any Club Championship
- Propose or second any Membership application
- Hold any office or vote at a General Meeting

Country Membership **\$10.00**
